

Peoples Veto Timeline: We will need a few days to organize petitions in advance of submitting to the Secretary of State, **we ask that you make every effort to turn your notarized, verified petitions into campaign Field Reps (see list below) by Thursday, September 12th.**

Here are step-by-step instructions for the full process:

Step 1: Sign the [Circulators Oath](#) (located on the bottom left of the petition) in the presence of a notary.

Step 2: Take your petition sheets to the appropriate town clerk for verification. Also, remember to take your [Certificate of Registration for Veto Circulators](#) to your town clerk where you reside. The clerk may verify your signatures while you wait. Otherwise, drop them off and wait for them to notify you when they are ready to be picked up. Be sure to leave the clerk your name and phone number. **If you do not have time to drop off at your town office, please contact the campaign Field Rep in your region (listed below).**

Step 3: Pick up your verified signatures from the town clerk!

Step 4: Turn in your verified petition sheets and your [Certificate of Registration for Veto Circulators](#) to your Field Rep. We need only one copy of your [Certificate of Registration for Veto Circulators](#). **Without this form your petitions cannot be counted.**
