

WORDS FROM OUR **EXECUTIVE DIRECTOR**



Friends of the League,

While there are many things for which we thank God in 2017, there are two great victories that stand out. In the spring, the Life Coalition (the CCL, the Diocese, Maine Right to Life, and Concerned Women for America) brought Stephanie Packer to Maine for a public hearing regarding our top legislative priority - - defeating Physician Assisted Suicide (PAS). Stephanie, a mother of four who was told by her California insurance company they would not pay for her chemo but would pay for the drugs to kill herself.

Although we unexpectedly lost a close vote in the Senate, we were inspired by Senator Dana Dow's powerful, pro-life floor speech to take on the long odds of defeating PAS in the Democrat controlled House. I believe the Lord rewarded the tremendous cooperation of the Life Coalition and blessed us with an unexpected victory when PAS was soundly defeated. This fall, we engaged in a campaign to defeat referendum Question 1, an attempt to place a casino in York County. There was great satisfaction in seeing our efforts with lawn sign placement, social media, radio interviews, and debate result in an historic defeat to those who wished to expand gambling here in Maine.

One of our first orders of business in 2017 was successfully advocating for Gov. LePage's moratorium regarding the commercialization of recreational marijuana. WRONGFUL DEATH BILL



The passage of the Wrongful Death bill was one of our top priorities for 2017. This bill would allow families like Abdi Maalin (pictured above) to sue negligent actors responsible for the death of their unborn children. Abdi's wife, Salima, who was eight months pregnant, was killed by a tired driver. The Wrongful Death bill would rectify the fact Maine is the only state in New England that prohibits compensation for the death of an unborn child. House Speaker, Sara Gideon, made stopping this bill a top priority in her caucus and suffered defeat by a single vote. We pray this injustice will be corrected and Wrongful Death will one day be passed here in Maine.



FAMILY POLICY ALLIANCE REGIONAL RETREAT

After failed attempts in past legislative sessions, a bill recognizing the First Amendment rights of the Amish not to wear hunter safety orange was passed this year. We were very thankful to work with Sen. Mike Carpenter (D) and Rep. David McCrea (D) (pictured above) on this very important bill affirming religious freedom. During this session, we continued to work with Sen. Amy Volk (R) and other advocates in legislation addressing human trafficking.
