


## **FAMILY RESEARCH COUNCIL**

# Pews to the Polls


The League made over 189 Voter Guides for all Maine races and distributed over 60,000 as well as numerous web and emailed copies.

## **CONVERSION THERAPY**

LD 912 was an attempt to take away parental rights to seek licensed counseling in line with their faith for a child struggling with gender identity or sexual orientation,

Over 270 pastors from Maine's Evangelical community signed CCL's unity statement condemning LD 912. Over 2,800 Maine citizens from all 16 counties, including over 340 licensed professionals, signed the League's petition opposing LD 912. That response from the Christian community encouraged legislators to successfully sustain Gov. LePage's veto and defeat this dangerous bill.

## **MARIJUANA**

Unfortunately, Maine citizens voted to legalize recreational marijuana in 2016. The League was part of a coalition that was able to successfully lobby for a moratorium delaying the implementation of the new law. Simultaneously, the League participated in the process of implementation advocating for stricter regulations that promoted public safety and health.

## **HUMAN TRAFFICKING**

Mainers are generally naïve when it comes to the issue of human trafficking in our state, but as the substance abuse crisis rages on, more and more women fall prey to this scourge. The League, once again stood with Sen. Amy Volk to advocate on several bills addressing this issue.

Through emails, Facebook posts and videos, we utilized our social media platform to encourage



Maine's citizens and leaders to ask Sen. Collins' to give Brett Kavanaugh a fair hearing. We were thankful for her courageous and influential speech which set the tone for Judge Kavanaugh's historic confirmation to the US Supreme Court.

## Prayer

We know we can accomplish nothing without God's anointing power on our efforts. Part of the League's vision is networking prayer partners in our state and bringing them together in scriptural unity. Our efforts were culminated in September when we partnered with Advancing Native Missions and East Auburn Baptist Church to bring Ruth Graham to Maine

for The Gathering --a prayer event focusing on the persecuted church.
